

CONSTITUTIONAL CONCERNS



Federal Travel Restrictions

- Federal government has broad powers to restrict foreign and domestic travel
- Commerce Clause
- Public Health Services Act

Restriction must not unduly restrict fundamental right to travel

State Travel Restrictions

States have broad general police powers

• E.g. to quarantine

But the Constitution limits State powers

- Fundamental right to travel
- Dormant Commerce Clause
- Privileges and Immunities Clause (Art. IV, § 2)

Private Restrictions

Risk of possible disparate impact discrimination based on

- Disability
- Race
- Religion
- Socioeconomic status
